This School was established in February 1964 under the Central Tibetan Schools Administration (CTSA) in New Delhi, which operates under the Government of India. Shri. D.V.S. Rawal served as the headmaster during that time. The school is situated in the most remote area of Arunachal Pradesh and specifically caters to the educational needs of Tibetan children from the Dhargyeling Tibetan Settlement. In July 2016, the administration of the school was transferred to the Sambhota Tibetan Schools Society in Dharamsala. Currently, the school is managed by the Sambhota Tibetan Schools Society, which operates under the Department of Education in Dharamsala. It functions as a coeducational day school at the primary level. The School currently has a staff of fourteen members, including both teaching and non-teaching staff, dedicated to providing education to Tibetan students.
